## Personal data processed by us

De Luchtfietsers process your personal data because you use our services and/or because you provide this information to us yourself. Below you will find an overview of the personal data that is processed by us:

- Surname and given name
- Date of birth
- Place of birth
- Address
- Telephone number
- E-mail address
- Bank account number

## Special and/or sensitive personal data?

Our website and/or services do not intend to collect data about website visitors who are under 16 years of age, unless permitted by either a parent or guardian. We are however unable to check whether a visitor is over 16 years of age. We therefore recommend parents to be involved in their childrens' online activities, in order to prevent collecting data about children without parental and/or guardian consent. ## Purpose and basis for processing personal data?

De Luchtfietsers process your personal data for the following purposes:

- Handling payments;
- Sending our newsletter;
- To be able to call or e-mail you, in case necessary to carry out our services.

## How long do we store personal data?

De Luchtfietsers does not store your personal data any longer than is strictly necessary to achieve the purposes for which your data is collected. We use a standard retention period of 2 years. This means that we delete your data 2 years after you have ceased being a member and/or cease being active. When a different retention period applies, we will inform you thereof. An exception applies in respect of all data that needs to be retained for a longer period of time pursuant to statute, such as data for the tax authorities.

## Sharing personal data with third parties?

De Luchtfietsers only provides data to third parties to the extent this is strictly necessary for the execution of our agreement with you or to comply with any statutory obligations.

## Cookies, or similar techniques, used by us

De Luchtfietsers uses technical and functional cookies, as well as analytical cookies that do not infringe upon a user's privacy. A cookie is a small text file that is used upon the first visit to this website, and is stored on your computer, tablet or smartphone. The cookies that we use are necessary for the technical operation of the website, and for your convenience. They ensure that the website works properly and remembers, e.g., your preferred settings. It also allows us to optimize our website. You can opt out of cookies by disabling storing of cookies in the settings of your internet browser. In addition, you can also use all the information that was previously stored via the settings in your browser.

## View, modify or delete data?

You have the right to view, correct or delete your personal data. Besides that, you have the right to withdraw your consent to the data processing, or object to the processing of your personal data by De Luchtfietsers, and you have the right to data portability. This means that you can make a request to us to submit the personal data we hold about you in a computer file, either to you or to send this to another organization mentioned by you.

You can request access, correction, deletion, data transfer of your personal data or request for withdrawal of your consent or objection to the processing of your personal data by writing to [post@deluchtfietsers.nl](mailto:post@deluchtfietsers.nl) .

For us to be able to verify that the request for access has been made by you, we ask you send us a copy of your id/passport along with the request. Please redact your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and Citizen service number (BSN) on this copy of your passport or id. This is to protect your privacy. We endeavour to respond as quickly as possible to your request, ultimately within four weeks.

De Luchtfietsers would also like to point out that you have the opportunity to file a complaint with the national supervisory authority, the Dutch Data Protection Authority. This can be done via the next link:
